China Trade Balance with the World

China, in 2020, registered a trade surplus of USD 535 billion, having increased USD 25 billion compared to 2016 and USD 105 billion compared to 2019.

China Trade Balance with Portugal

China was the 15th customer of Portuguese exports of goods in 2020, with a share of 1.1% in total, occupying the 6th position in terms of imports (4.5%). Over the period 2016-2020 there was an average annual decrease in exports of 2.9% and a growth of 14.2% in imports. The balance of trade in goods was unfavorable to Portugal, having presented a deficit of 2 500 million euros in 2020.

Portuguese Ambassador to China, José Augusto Duarte, says for the two counties, materialistic gain is not as important as having common understanding.


